

One item that is getting a lot of attention right now is **Infection Prevention and Control** in the clinic and laboratory setting. Members should know that the College is currently working with **Public Health Ontario**, members of the profession, and the provincial Associations to examine and update the current College Infection Control Guidelines. Because these current guidelines are very limited in their scope and only refer to Instrument Cleaning and Sterilization, a more comprehensive set of guidelines is being developed in conjunction with the College of Dental Hygienists of Ontario and will be available within the coming months. In the meantime, Public Health Ontario has provided the College with a **list of resources for denturists** that address some specific aspects of infection prevention and control. Please feel free to contact the College if you have any questions regarding Infection Prevention and Control. If we do not have the information readily available, we will be happy to liaise with Public Health Ontario to get the information you require.

I trust that the information included in this email is useful to you. It is a challenge to determine the best way of communicating with members of the profession because there are many options and each individual has their own preference. To determine the best way to communicate with you, we will be sending out a short **Communication Survey** in the next couple of weeks. The results of this survey will assist the College in determining the best strategy for communicating with you.
