College Welcomes New Public Appointee

You will know that the College relies on the participation of members of the public who are appointed by the current government or Council to provide the public voice in decisions that are made by Council and its Committees. On behalf of Hanno Weinberger, President of Council, I am pleased to welcome Ms. Lileath Claire as a Public Appointee to the College Council. Lilieath brings a wealth of knowledge (MBA-York, MSc-Logistics and Operations Mgmt-Liverpool) and subsequent experience with Sanofi, a global Biotechnology/Pharmaceutical firm. In addition, Lileath is very active in her community where she currently serves as Secretary and Director of the Board of the Mississauga Furniture Bank, as a Volunteer – Researcher for Regeneration Community Outreach, a community social service organization, and as a member of the Elder Board of the Portico Community Church. By-law Amendment - Honorary Status - "Retired"

As you will have learned, Council approved a By-law amendment that provides for the Honorary Status of "Retired" for individuals who have resigned their Certificates of Registration but wish to maintain some connection with their profession and the College. The Retired Status application will be available on March 1st, 2020. The application forms and information will be posted closer to the opening date. The application fee and renewal fee have both been set at \$50 + HST. Stay tuned for further instructions on how to apply!

Program for the Prevention of Sexual Abuse of Patients

At the September 6th 2019 meeting, Council adopted a number of items developed by the College's hard-working Patient Relations Committee that are related to the College's Sexual Abuse Prevention Program: Revised Sexual Abuse Prevention Plan and Patient Sexual Abuse Frequently Asked Questions. These updated items are posted on the College's website and you are encouraged to familiarize yourself with these items.

Standards of Practice:

Professional Collaboration

At the June 14th, 2019 meeting, Council adopted the Standard of Practice: Professional Collaboration for implementation on January 1, 2020. This Standard describes the College's expectations for Registered Denturists working in collaborative health care teams. Denturism Educators

At the September 6th, 2019 meeting, Council adopted the Standard of Practice: Denturism Educators for implementation on January 1, 2020.
