# Important Changes to the 2020-2021 Renewal Fee Payment Schedule

March 20, 2020

## Important Changes to 2020-2021 Certificate of Registration and Health Profession Corporation Certificate of Authorization Renewal:

As a result of the COVID-19 pandemic and its impact on the financial position of many, if not all, Registered Denturists, the following changes have been made to the upcoming renewal deadlines:

- 1. Online submission of the Certificate of Registration renewal and Certificate of Authorization renewal questionnaires and documentation remain due by **April 14<sup>th</sup>, 2020** at midnight.**

The information contained in the renewal documentation is important for College record keeping and the information that the College provides on the Public Register. We thank you for completing the online questionnaire before the April 14<sup>th</sup> deadline.

## 2. Renewal Fee Schedule

You may wish to pay your entire renewal fee at the time you submit your documentation / renewal questionnaire. You may do so, simply follow the directions for online renewal.

**However, payment can be submitted at a later date (see the payment schedule below).**

**If you wish to pay later, click on “Invoice Me” on the payment screen at the end of the renewal process. This will capture your renewal submission and defer your payment until the deadlines noted below.**

**You can log back into the Member Portal and pay unpaid invoices at a later time.**

- 3. Instalment Option is now available:**

	Certificate of Registration	Certificate of Authorization
<b>First Instalment</b> Due May 29 <sup>th</sup> , 2020	\$950 + HST	\$175 + HST
<b>Second Instalment</b> Due October 30 <sup>th</sup> , 2020	\$950 + HST	\$175 + HST

#### 4. What If I Have Already Renewed and Paid?

As you will appreciate this is a rapidly developing situation and we hadn't anticipated the need to provide for a change in the Renewal fee schedule when the Renewal process began. If you have paid and need some financial relief, we are able to provide a refund of 50%. This is a bulky accounting process but are happy to provide this refund in cases of the need for some financial relief.

#### 5. 2019-2020 Annual CPD Requirements are still due by **April 14<sup>th</sup>, 2020**. There are several online CPD opportunities provided by the College:
