# Canadian Dental Care Plan

Services and Details Announced

Dear Registered Denturists,

On Thursday, February 8, 2024, the Government of Canada announced further details regarding the Canadian Dental Care Plan including the services covered, fee structure, and the dental benefits guide.

The majority of the services covered under the CDCP will be available as of May 2024 when the first cohort of the CDCP clients will begin to receive services. Some oral health care services such as initial placement of partial dentures will require preauthorization - and will be available beginning the fall of 2024.

Along with the list of services covered, the fee structure for Denturists and all other oral health care professionals have also been published.

The CDO is excited for the roll out of this historic program over the coming months. We believe this important initiative will increase the public's access to denturism care and service. We thank all stakeholders, Denturism regulators including the College of Alberta Denturists, representatives from the Denturism profession, including the DAC, who worked diligently with the Government of Canada on this groundbreaking initiative.
