- Select **Denturists Multi-Jurisdictional Exam** and begin registration

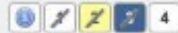
Day of the Exam

- The denture can be placed in the mouth after healing is complete.
- The denture is temporary and is replaced after healing is complete.
- The denture can be kept as a long-term prosthesis.

Determining the Pass Score

- Determined by practicing denturists utilizing the Modified Angoff Standard Setting Method, the most widely used method in North America.
- Determined independently of candidate performance.
- Using this method, it is possible that all candidates can be successful.

Ensuring your score is fair and valid

- Following the examination, all items are reviewed to ensure that they have functioned in the anticipated fashion.
- Items not meeting psychometric criteria are reviewed by a subgroup of the multijurisdictional exam advisory group and a determination about the item's status is made.
- Factors impacting candidate performance, documented in incident reports, are taken into consideration before a candidate's score is finalized.

Results

- Results of the registration examination will be sent to each candidate, via email, within 6-8 weeks of the completion of the examination.
- Performance reports will be provided for unsuccessful candidates.

Performance Reports

- A performance report provides an analysis of the examination competency areas.
- Provides specific feedback about the unsuccessful candidate's performance in each of the five competency areas tested in the MCQ.

Incident Reports

- If you experience anything out of the ordinary that may have negatively affected your exam performance.

- At lunch break or after the exam ends
- By end of day

- You must document your incident on the day of the exam should you wish to lodge an appeal.

Appeals of Results

Appeal may be based on three grounds:

Candidate illness on examination day

- Must be supported by medical documentation by a licensed healthcare professional within **3 business days** of the examination.

Personal emergency

- An unforeseen emergency or trauma incident, such as the death or serious, sudden illness or injury of a close family member or close friend.

Procedural irregularities

- For example, fire alarms or power outages

Appeals of Results

- Your appeal must be received by the College within 15 business days from release of exam results.
- Appeals do not result in remarking or rescoring of your examination mark.
